## Introduction

The Disability Rights Center – New Hampshire (DRC-NH) is a statewide non-profit organization that protects, advances, and strengthens the legal rights and advocacy interests of all people with disabilities across New Hampshire. In Collaboration with the DRC-NH, my leadership placement focused on developing a series of webpages that share information and resources about various types of assistive technology (AT), including individuals' rights to access AT and how the DRC-NH can help.

## Assistive Technology (AT)

Assistive technology includes any item, piece of equipment, or product that increases, maintains, or improves the ability of individuals with disabilities or impairments to function. Increasing knowledge of and access to these devices plays a vital role in reducing barriers faced by individuals with disabilities.
